AGREEMENT BETWEEN WILDCATS YOUTH HOCKEY AND
PARENT/RESPONSIBLE PARTY FOR THE 2011-12 YOUTH HOCKEY SEASON

This agreement is entered into by Wildcats Youth Hockey (“Wildcats”) and _____ (“Parent/Responsible Party”) on behalf of and/or Guardian or Responsible Party for _____ (“Player”).

In exchange for the opportunity to participate in Wildcats Youth Hockey for the 2011-2012 Season, Parent/Responsible Party agrees to:

1. Pay dues of \$299, either up front prior to September 15, 2011 or through the Wildcats approved payment plan. If the Wildcats approved payment plan is used, the Parent/Responsible Party agrees to make a non-refundable \$100 deposit **AND** provide the Wildcats with two (2) additional post-dated checks for the amounts and dates stated on the Wildcats payment plan prior to or on October 1, 2011. A player’s participation on the team will be denied if Parent/Responsible Party defaults in the full and timely payment of dues. There is a \$25 fee for all returned checks.
2. Ensure that Player remains in good standing with USA Hockey, the Texas Amateur Hockey Association, the Texoma Youth Hockey Association, the Wildcats, and the facilities where play occurs.
3. Ensure that Player, Parent/Responsible Party, and Spectators in attendance for Player (i.e., parents, siblings, grandparents, friends, etc.) comply with the Standards of Conduct established by USA Hockey and any additional standards established by the Wildcats or the coach. The Texas Amateur Hockey Association, Texoma Youth Hockey Association, and Wildcats have all adopted the USA Hockey Standards of Conduct. It is the responsibility of the Parent/Responsible Party to be familiar with such Standards of Conduct. If you wish to obtain a copy of the Standards of Conduct, please see Sean Fish for information on how to access this information. Additional standards established by the League will be provided to Parent upon request.

September 15, 2011: Every player who registers with Wildcats Youth Hockey must have paid a \$100 deposit and submit 2 postdated checks by October 1, 2011. Registration is open now and payments may be mailed to the Wildcats at the address on page 1. You can make any size payment that you want as long as you have paid the \$100 deposit by 9/15/2011. Postdated check dates and amounts are \$105 on 11/1/11 and 12/1/11.

IF A PLAYER'S REGISTRATION FEES ARE NOT CURRENT, **THERE WILL BE NO GRACE PERIOD.** THE PLAYER WILL NOT BE ALLOWED TO PARTICIPATE IN PRACTICES, GAMES, OR ANY OTHER WILDCATS YOUTH HOCKEY ACTIVITIES UNTIL ALL FEES ARE CURRENT. For example, if a Player has not made the required \$200 deposit AND submitted postdated checks for the remainder of the season by 9/15/2011, the Player **will not** be allowed to practice, play in games, or participate in any other Wildcats Youth Hockey activities until deposit and 2 checks are submitted.

Postdated checks will be held by the Wildcats Organization and will not be deposited until the date on the check at the earliest. If any check is returned for insufficient funds, the person signing this form is responsible for all fees incurred by the Wildcats as a result of such default, and must pay such fees along with the remaining dues owed. The Player will not be permitted to participate in practice, games, or any other Wildcats Youth Hockey activities until such default is corrected.

NOTE: Any Wildcats player leaving Youth Hockey (for any reason) after November 15, 2011 will forfeit all monies submitted.
